In consideration of you accepting my entry application to participate in the Live Oak 10k/5k and Family Fun Run fundraiser event on Saturday, September 22, 2018 (the "Event"), co-sponsored by the Santa Cruz County Department of Parks, Open Space and Cultural Services and the Boys and Girls Clubs of Santa Cruz County (BGCSCC), I, and/or the children on whose behalf I am signing this form, hereby WAIVE AND RELEASE ANY AND ALL RIGHTS, LIABILITY, CLAIMS, AND CAUSES OF ACTION OF ANY NATURE WHATSOEVER I may have against the County of Santa Cruz, the Santa Cruz County Department of Parks, Open Space and Cultural Services, the Boys and Girls Clubs of Santa Cruz County, Santa Cruz County Sheriff's Activity League, Harbor High Cross Country Team, Santa Cruz Track Club, South Bay Regional Public Safety Training Consortium, and their respective officers, directors, employees, agents, assignees, licensees, and volunteers, and any other cooperating entities, and their respective officers, directors, employees, representatives, and volunteers (the "Released Parties") arising out of or relating, directly or indirectly, to any claim, loss, damage, or injury, including death, that I, or the children on whose behalf I am signing this form, may suffer or sustain, or that any property belonging to me may sustain, while participating in the Event, REGARDLESS OF WHETHER SUCH LOSS IS CAUSED BY THE NEGLIGENCE OF THE RELEASED PARTIES or otherwise and regardless of whether such liability arises in tort, contract, strict liability, or otherwise, to the fullest extent allowed by law.
