

Department Directors establish daily/weekly activities/programs that were intentional, met targeted learning objectives and underscored the organizational goal to make the entire club a "learning center" so that every moment in the Club is a "learning experience."
- Established an internal Academic Success team (Education Directors at each Clubhouse) to share best practices and improve program delivery and impact. The team's primary area of focus is how to track academic data on Club members using report cards and school-based homework/grade websites.
- In partnership with Bothman Construction and the NFL's PLAY 60 Campaign, the San Francisco 49ers converted part of the Joe & Linda Aliberti Clubhouse asphalt space into an a brand new, wind protected turf field for Club members.
