## **How to Make Gifts of Securities**

With the tax-saving advantages achieved by donating appreciated securities, many friends and supporters of the Boys & Girls Clubs of Santa Cruz County find they can be more generous than they might otherwise be with a gift of cash.

Donations of marketable securities can be as easy as advising your broker or agent to transfer the stock electronically to the Boys & Girls Clubs of Santa Cruz County brokerage account, or delivering your stock certificate assigned to "Boys & Girls Clubs of Santa Cruz County."

#### **Recorded Date of Gift**

The date the gift is made is the date that Boys & Girls Clubs of Santa Cruz County receives irrevocable control and ownership of the security. This normally occurs in one of two ways:

 The security is received by the Boys & Girls Clubs of Santa Cruz County broker or agent via electronic transfer;

OR

 The security is hand delivered, mailed or emailed to a Boys & Girls Clubs of Santa Cruz County representative by the donor or his/her broker or agent along with Stock Power and Guaranteed Signature.

Gifts of stock options, closely held stocks or stocks with any restrictions must be evaluated by the Club to determine if the gift can be accepted. Donors should be advised by their personal accountants and/or financial advisors to calculate their charitable tax deduction and the value of their gift of securities.

## **Electronic Transfer**

## Mail

If sending by mail, please send the Stock Certificate and a Stock Power and Guaranteed Signature separately. Include a cover letter noting that the donor wishes to gift the stock to the Boys & Girls Clubs of Santa Cruz County and request that the Boys & Girls Clubs of Santa Cruz County broker sell on good delivery. If the stock is in multiple names, all individuals must sign the stock certificate and letter to the Club's broker. Send the letter and stock to:
